

Reference is made to our letter of November 5, 2015.

A review of the individual deceased personnel file by the Department of the Army Human Resources Command, Casualty and Mortuary Affairs Operations Center, 1600 Spearhead Division Ave., Fort Knox, KY 40122 has determined that the correct date of death of Sergeant John P. Ray, service number 34005401, is June 13, 1944.

Based on the Department of the Army's findings, Sergeant Ray's grave marker at the Normandy American Cemetery and Memorial will be inscribed as June 13, 1944 rather than June 7, 1944 as currently inscribed.
