Dear Mr. Siddall:

l am responding to your email of October 26, 2015 regarding the grave marker inscription of Sergeant John P. Ray, service number 34005401, interred at the Normandy American Cemetery and Memorial.

As stated in our letters of July 14 and September 30, 2015, a completed or perfected. FOIA request needs to state the requester's willingness to pay any applicable fees or provide sufficient justification to support a fee waiver. Your imperfect FOIA request does not include such a statement.

Additionally, requests for processing under the Freedom of Information Act must be in compliance with FOIA laws outlined in FOIA 5 Indied States Code Section 552, which specially requires federal agencies to make their records available to persons who make a proper request for them. A completed FOIA request must be in writing, reatonably describe the requested records, and indicate agreement to pay applicable fees. The FOIA is god a process for presenting questions or to otherwise obtain information, conversational content or requests for specific action to be taken by an agency of the U.S. government.

Contrary to the statements in the attachment accompanying your email, the program of permanent interment of U.S. World War II Dead, as well as the determination of the data to be inscribed on the grave markers at the overseas American milliary cemeteries, was carried out by the American Graves Registration Service of the Quartermaster General of the War Department, not this Commission.

As an independent civilina agency of the U.S. government, this Commission has no authority to change or correct military service records. Therefore, in the interest of determining Sergeam Ray's date of death, a request, to include your email and its enclosed narrative, have been sent to the Department of the Army Human Resources Commisand, Cassulty and Morturary Affairs Operations Center, 1600 Separchead Division Ave., Fort Knox, KY 40122, which has executive authority over the World War II deceased personnel files, for a determination of SGI Ray's date of death, Bassed on the Department of the Army's findings, SGI Ray's grave marker will be changed if

Mr. Siddall:

On behalf of Secretary Cleland I am responding to your recent query.

In July I received a phone call from the family of SGT. Ray who learned that his headstone was scheduled to be replaced through correspondence from you. The family asked that the headstone not be replaced and explained why. As such, I directed the cemetery to hold the new headstone and not replace the original. Through a miscommunication at the cemetery, the new headstone was installed in early August. On August 8, I was once again called by the family who became aware that the new headstone was installed and asked that the original be returned. I immediately contacted the cemetery and asked them to return the original headstone to the grave at the request of the widow. SGT Ray's widow then mailed me a formal request to keep the original in place. You already have a copy of the letter SGT Ray's widow sent to this office via certified mail on August 8.

The Secretary made the decision to keep the original headstone in place based on my recommendation that we should honor the wishes of primary next of kin. SGT Ray's widow, Mrs. Paula Ray Guidry, was his primary next of kin at the time of his death and at the time of determination for the disposition of SGT Ray's remains.

With the passage of time, headstone inscriptions marking those honored gravesites have taken on a significance and personal meaning for immediate family members that are beyond any outside observer's ability to comprehend. They have endured much on behalf of our great nation. ABMC has long recognized its legal and moral obligation to the next of kin who suffered the greatest loss, and made the decision to permanently honor their loved one with interment in an overseas military cemetery. Our agency owes it to surviving next of kin to recognize that same moral obligation when evaluating requests for changes to the headstone inscriptions.

We consider this matter closed.

The mission report states that the 612<sup>th</sup> Bomb Squadron, 401<sup>st</sup> Bomb Group/H, was briefed on Saturday, Sept 9, 1994 at 0400 hours; piloted by 1LT David Loughlin, took off at 0816 hours for a bombing mission of the railroad yards at Mannheim, Germany; received at direct hit and broke in half at 20,000 feet. Seven crew members were killed; two survived. Several other members of the members of the crew, all with date of death as September 9, 1944, are also interred at the Lorraine American Cemetery as follows:

SSGT Arlo W. Dralle, 364555642, Plot B, Row 34, Grave 27 - Waist Gunner 1LT Charles F. Meredith, O-818292, Plot B, Row 33, Grave 15 - Co-pilot SSGT John B. Punte at Plot B, Row 33, Grave 33 – Ball Turret Gunner 1LT Edwin F. Sedlak, 0761473, Plot B, Row 36, Grave 16 - Bombardier TSGT James L. Sommers at Plot B, Row 33, Grave 17 - Radio Operator

1LT R. L. Bernard, Navigator and TSGT O.E. Livingston, Engineer/Top Turret were taken as prisoners of war and survived the war.

SGT D.C. Messex, Ball Turret Gunner also listed in the crew roster did not fly this mission. He also survived the war.

The 43<sup>rd</sup> Bomb Group/H, consisting of the 63<sup>rd</sup>, 64<sup>th</sup>, 65<sup>th</sup> and 403<sup>rd</sup> Bomb Squadrons, served in the southwest Pacific Theatre of Operations from 1942 to 1945.

3. ABMC burial records confirm that the following crew members listed on the missing air crew report are interred as follows: 2LT Morton P. Gross, O-727336, 67th Bomb SQ, 44th Bomb Group is interred at Plot B, Row 17, Grave 43, Normandy American Cemetery. CAPT Clyde E. Price, O-398584; 1LT Jacob A. J. Augenstene, O-789432, SSGT Lewis J. Fleshman, 12035272, and TSGT Donald E. Jester, 17023590, all with date of death of March 8, 1943, are interred at the Ardennes American Cemetery. TSGT Dalton Snell, 17032555 is interred at private cemetery in Arkansas and SSGT Roy E. Gosline, 14069419 is interred at private cemetery in Alabama. All crew members are recorded as being temporarily interred at the St. Andre U.S. Temporary Military Cemetery at Evreaux, France.
