The \$75 maximum allowance by the Government toward interment expenses includes but is not limited to the payment of one or more of the following items: Hearse hire from the railroad station to your home, the funeral home, church, cemetery, or any other place designated by you; vault; church services; newspaper notices; traesportation for friends and relatives to and from cemetery; and the services of a funeral director.
- 4. Reimbursement by the Government is made only to the person who hald from his personal funds the expenses of or incident to interment in a private or civilian cemetery. Receipted of this are not required to accompany this darm. Any expenses over any above the 675 maximum sites be borned by the person who incurred of hald the additional expenses.



EXPLANATION OF BOX "E

- 1. When the remains are delivered to you at Government expense prior to burial in a national or post constary, you are responsible for alk additional expenses necessary to deliver the consing from that point to the national or post cemetery grave site. However, you may be entitled to an allowance for the cost of transporting the remains from your home to the national or post cemetery grave site subject to the conditions outlined in paragraph 2 below.
- 2. Reimbursement of granaportation expenses is allowed only when the cost to the Government to deliver the remains to you be the test than what it would have cost the Government to deliver the remains direct to the national or post cemetery of final interment. 


