




- 15 April 44 In compliance with First U. S. Army Orders, Company Headquarters and Fourth Platoon to Knowle Camp, Bristol, England; Second Platoon to Fifth Engineer Special Brigade, Swansea, Wales; First Platoon to First Engineer Special Brigade, Truro, England; Third Platoon to Sixth Engineer Special Brigade, Paignton, England.
- 28 April 44 First Platoon suffered heavy casualties while engaged in problem with First ESB. Six (6) EM killed, 1 Officer and nine (9) EM missing.

- 9 June 44 Third Platoon closed beach cemetery after interring 457 Americans.
- 11 June 44 Third Platoon moved to cemetery established at St. Laurent Sur Mer by Second Platoon.
- 12 June 44 Fourth Platoon Detachment processed 97 German dead at 101st Airborne Cemetery.
- 18 June 44 Fourth Platoon closed Utah Beach cemetery after interring 368 bodi
- .19 June 44 Fourth Platoon moved to Orglandes and set up German cemetery at si selected by 7th Corps.
- 20 June 44 Company Hq and First Platoon left Knowle Camp, Bristol at Oll5, per First U S Army orders, and arrived Saltram Park, Plymouth, 1500.


